


• Homelessness of those who have served this country is unacceptable. This legislature can restore dignity to individuals who have made sacrifices. The failure to act remains a national



RESULTS

- The total number of incidents reported by districts increased by 8,753 incidents from 17,386 in 2010-11 to 26,139 in 2011-12.
 - Demonstrating howbullying cases wereextremely underreportedbefore the bill was passed.

POLICY STRENGTHS:

- Focuses on students; mental health.
- Equips staff with better tools to handle these situations.

POLICY WEAKNESSES:

- Inconsistent Enforcement
- Focus on Reporting vsPrevention
